## **COMMON SENSE AND GOOD NEIGHBOUR SUGGESTIONS:**

Although the items mentioned below seem like common sense, some visitors, renters and a few cottagers seem to be oblivious to basic lake etiquette concepts.

#### Swimming and General Water Activities:

Please tell your children to refrain from screaming. It is annoying and disconcerting to your neighbors. Worse- if they are continually screaming, no one can tell when there is an actual emergency. Voices can be heard for great distances over water, please respect your lake and be aware of foul language and late night banter while on the water. **Boating:** 

Huge waves can wreak havoc on docks, boats, loon nests and shoreline erosion. Please be observant and adjust your speed to minimize the size of wake your boat generates. All boats are requested to follow the 10km/h rule within 30 meters of shore, (except when pulling out a skier, boarder, tube) in which you must try to access open water at 90 degrees from shore as best as possible.

#### **Tubing:**

Tubing is fun for all and most enjoy it. Tubing can be done in calm or choppy water, why not respect the few times our lake is calm and try to give this time to the skiers and wake skaters who need calm water. This is usually before 10am and after 6pm. The back channel area is also not a safe area to tube given its narrow width and lack of control in a tube.

#### Wakeboarding:

The bigger the wake the better right? Please remember the 30m law from shore. You are liable by law for any damage your wake creates to vessels, docks or shorelines.

#### Fishing:

Please respect people's privacy and property and refrain from approaching docks and shorelines when folks are trying to enjoy it.

#### **Outside Lights**:

Many Morrison Lake residents enjoy the night sky. High intensity and misdirected outdoor lights obliterate the night sky. Please help to reduce light pollution. The OPP advises cottagers to use motion timers for security and remind us that inconsiderate lights can get you charged with disturbing the peace. Give the environment and your neighbors a break, turn off the lights.

## **MUSKOKA LAKES NEWS**

#### Notes from the Muskoka Lake Associations' Meeting on April 25, 2009 From Lola Bratty

The discussion focused on:

#### Ward Representation in Gravenhurst:

Background: this was made part of the 2007-10 Council strategic plan and has been before council several times. At the most recent vote the majority on council decided on no change.

A chart was presented showing the current wards and population distribution – see the petition form – and the appropriate sections of the Municipal Act were distributed. The act says that if 1% (130) electors presented a petition asking council to divide or redivide the wards or to dissolve the existing wards Council must pass a by-law in accordance with the petition within 30 days. If council fails to act the OMB can be asked to change the wards. A copy of the act was provided to attendees. All agreed that the current distribution of wards and voters is unfair. Attendees agreed to seek signatures on the petition from their membership and others. This will be done over the summer. Lola will collect the petition forms from the associations by July 21. The signed petition forms will be presented to the mayor and council at the next meeting with the request that the wards be redefined to provide for a better balance of population and representation.

#### Taxes:

Spending in Gravenhurst is up 3.6%, the district taxes will be increased by 4.4%, development charges do not recover infrastructure costs incurred to provide for growth. Hence taxes and debt will rise. It was agreed that there is not much to be done this year except on development charges along with providing information to membership.

#### **Planning:**

There are several issues here: the development of the new zoning by-law; the handling of exemption requests, the enforcement by the buildings department inspectors.

It was agreed that the perspective of the town staff needs changing, from assuming exemptions are the acceptable norm to looking at the cumulative impact of changes on the 'commons', i.e. on the health and character of the lakes. It was felt that exemptions should be just that – exemption not the norm.

Several actions were proposed – the Associations will again stress stewardship to their members via workshops, newsletters etc. Lola will draft a letter to go to the mayor and Planning Department requesting staged consultations during the development of the zoning by-law

Lola will generate a preliminary list of items we want changed or improved in the zoning by-law, e.g. definition of a kitchen, redevelopment restrictions, enclosing of decks and the resultant creep towards the lakes. All Associations are asked to think about applications on which they have commented in the past few years and bring to her attention any areas where they have concerns or see the need for change.

#### Community vision and sustainability:

The changes over the past few years in town are not necessarily seen as desirable from the point of view of their impact on the character of the town. Development is not the issue as much as its character. We need to have a shared vision for the town that provides for its health and economic development and for its sustainability. It was agreed that we could encourage this process to be undertaken. There are others who have part of the responsibility, for example the Heritage and Environmental Advisory committees and other Associations. The GGRA will provide leadership too.

Lola will draft a letter to go to them and to the mayor urging a visioning process to achieve something that all citizens can buy into and ensure that heritage, environment, character and the economy are addressed. Her draft will be circulated for comment.

#### **Environment Advisory Committee:**

2 members of the EAC joined us. They will be having a meeting with association representatives on September 26 to obtain input regarding lake priorities pertinent to the environment. You will hear further.

#### Stewardship and Water Quality:

Lola is prepared to put together a presentation on water quality using the staff and data from the District, the MLA and MOE relevant to each lake and on understanding the impacts of phosphorus and bacterial problems. Please let her know if you would like this for your association AGM or other meetings. The earlier the better as there are lots of other lakes competing for the weekends.
